DATA PROTECTION PRIVACY POLICY.

We care about the processing of your personal data. Protecting your privacy is one of our highest priorities. This statement explains how and what type of personal data is collected, what it is collected for and with whom it is shared. Please read this notice carefully.

FOR WHAT PURPOSE DO WE TREAT YOUR PERSONAL DATA?

The personal data provided by you will be processed in order to manage the commercial relationships that we develop and, in particular, the products and services that we market and to manage the activity developed by GERMÁN JOYEROS S.A. that turns in traffic under the name of Germán Joyero. Therefore, they will be incorporated into the treatment systems whose sole owner is GERMÁN JOYERO S.A. access being restricted to any other person outside of it.

In no case GERMÁN JOYERO S.A. will use your personal data for purposes other than those mentioned above, nor will it communicate them to third parties without your prior and express consent, and undertakes to keep due professional secrecy and to establish the technical, organizational and security measures necessary to safeguard the information in accordance with the requirements established by the European Regulation.

As an applicant for our services, you guarantee that the information provided is true, accurate, complete and up-to-date and you will be solely responsible for any direct or indirect damage or loss that may be caused as a result of the breach of said obligation. In the event that the data provided belongs to a person other than you, you

must inform them of the aspects contained in this policy and obtain their authorization to provide them to GERMÁN JOYERO S.A.

If the request or service were requested by a legal entity, the consent granted by the proxies or authorized for the purposes of article 21 of Law 34/2002, will be understood to be given both in their own name and in that of the legal entity to the one it represents.

GERMÁN JOYERO S.A. It is an independent company and in the case of wanting to claim the exercise of the rights of access, rectification, deletion, opposition, limitation to its transferability and portability, they must be exercised before this entity.

FOR HOW LONG WILL WE KEEP YOUR DATA?

The data that you have provided us in requesting the services we provide will be kept for a maximum period of one year, counted from the last confirmation of the interest made by you, if the contract is not concluded.

In the case of entering into the contract, the data will be kept as long as it remains in force and, even afterwards, for as long as some type of responsibility may be required from GERMÁN JOYERO S.A. derived from its status as a seller; that is, for a maximum period of five years.

WHAT IS THE LEGITIMATION TITLE FOR THE TREATMENT OF YOUR DATA?

The legal basis for the treatment of the data provided to GERMÁN JOYERO S.A. is the execution of the service requested by the petitioner and provided by GERMÁN JOYERO S.A.

The offer of products and services is based on your request and the prospective offer of said products and services and on the consent that is requested, without in any case the withdrawal of this consent conditioning the execution of the subscription contract.

TO WHICH RECIPIENT WILL YOUR DATA BE COMMUNICATED?

The data for which GERMÁN JOYERO S.A. is responsible They will not be communicated or transferred to third parties, except legal obligation.

WHAT ARE YOUR RIGHTS WHEN YOU PROVIDE US WITH YOUR DATA?

At any time you have the right to obtain confirmation from GERMÁN JOYERO S.A. about whether we are treating personal data that affects you.

You also have, at any time, the right to access your data; to request their rectification if they are inaccurate or to request their deletion; to request the limitation of the treatment in the legally established circumstances, in which case we will only keep them for the purposes of exercising or defending claims; to oppose the treatment, in which case we will stop treating them, except for legitimate reasons or in the exercise or defense of claims and the portability of the data.

You can also withdraw your consent to the processing of your data at any time, without affecting the legality of the processing based on the consent given prior to its withdrawal.

To facilitate the exercise of your rights, we offer you the models that you can download on our website.

Finally, GERMÁN JOYERO S.A. It reminds you that you can file a claim with the Spanish Agency for Data Protection, as the Data Protection Control Authority, especially when you have not obtained satisfaction in the exercise of your rights, by accessing its website aepd.es.
